NOTICE OF RACE

1- ORGANIZATION AND COURSES

- 1.1 The XXXI Edition of the MARE NOSTRUM is organized by CLUB NÀUTIC GARRAF, under delegation by Real Federación Española de Vela and with the collaboration of Federació Catalana de Vela.
- 1.2 The XXXI Edition of the MARE NOSTRUM, is a Regatta that will be Qualifying for Spanish Cup Single-handle and Double-handle for ORC boats and for Catalan Championship Single-handle, Double-handle and Mini 6.5.
- 1.3 The XXXI Edition of the MARE NOSTRUM course will consist in:
 - Starting in Club Nàutic Garraf, all the Balearic Island for starboard and finishing in Club Nàutic Garraf. For Single-handle, Double-handle and full crew Groups.
 - Starting in Club Nàutic Garraf, all the Balearic Island and Columbretes Island for starboard and finishing in Club Nàutic Garraf. For Mini 6.5 Group.

2- RULES

- 2.1 The Regatta is governed by the following rules:
 - a) Regatta rules as defined in the WORLD SAILING (WS)'s Sailing Regatta Regulation in force
 - b) Cruiser Technical Regulation 2020 and annexes.
 - c) ORC Measurement Regulation and IMS Measurement, Habitability and Equipment Rules.
 - d) [DP] Mini 6.5 Class Rules.
 - e) Convention on the International Regulations for Preventing Collisions at Sea (COLREGs).
 - f) World Sailing special rules for Off-Shore Regattas, Category 3 with live raft and index $> 103^{\circ}$.
 - g) FCV Sports Guide in whatever applies.
 - h) [NP][DP] Annex A Security protocol in relation to COVID-19
 - i) Plan in relation with COVID-19
 - 1.- The entry at yacht club is forbidden to anybody their body temperature exceeds 37,5°C, also the person refuse to pass the temperature control. This decision will be not ground to request for redress (modifies RRS 62.1 (a)).

- 2.- A breach of "Security protocol in relation to covid-19" could be incurred, with hearing, in a Discretional Penalty imposed by the Protest Committee.
- i) [NP][DP] All participants and support staff will follow any reasonable instructions given by a member of the organization or Race Committee.
- k) [NP][DP] Each boat's representative must have installed WhatsApp on its phone and must be part of XXXI MARE NOSTRUM group.
- 2.2 In all the rules that govern this regatta, the notation [NP] refers to the fact that an infraction of this rule will not be a reason of complaint between boats. (It modifies the RRV Rule 60.1 (a))
- 2.3 Between the official sunset time and the official sunrise time, Sailing Regatta Part 2 from Regulation is replaced by COLREGs Part B.
- 2.4 In case of discrepancies between the official's texts, the Spanish version will prevail.

3- PARTICIPANTS

- 3.1 Boats with an ORC Measurement certificate for 2020 may participate in this regatta. Those who are not available of an official certificate may request it through the Organization of the race.
- 3.2 Boats with an **ORC** certificate may participate in Single-handle, Double-handle and Full-crew as well as **Mini 6.5 Class Boats Double-handle**. It is required a minimum of 6 boats ORC to consider this as a Class. In Mini 6.5 Class, in case of not reaching 5 boats, they can participate by presenting its current ORC certificate.

4- ELIGIBILITY

- 4.1 Participants must comply with the eligibility conditions written in WS 19 Regulation and in RFEV Prescriptions.
- 4.2 Participants with legal residence in Spain or that compete in an adscript boat in a Spanish Club, must be in possession of the Sports Federative License for 2020.
- 4.3 Mini 6.5 Class boats must have the security equipment required in a level B regatta.

5 ADVERTISING [NP][DP]

- 5.1 Participants may be display individual advertising according to Regulation 20 of the WORLD SAILING and RFEV requirements.
- 5.2 Participants may be required to display the advertising in accordance with Regulation 20.4 of the WORLD SAILING Advertising Code.

- 6.4 After 6.00 pm on 24th August 2020 is not accept amendments in Measurement Certificate.
- 6.5 After 10.30 am on 25th August 2020, the Organizing Committee will no longer accept any entry and Measurement Cerficate. (modifies rule 78.2 RRS).
- 6.6 All boats must be require for Race Committee in Club Nàutic Garraf before 10.30 am 25th August 2020, for stamping, revision and security control.

A responsible person must be require for boat or boat keys are deposited in Race Office.

- 6.7 Entry fees shall be paid in website to **CLUB NÁUTIC GARRAF**. <u>www.clubnauticgarraf.com</u>
- 6.8 Entry is not finish until the participants register is completed.

7- PARTICIPANTS REGISTER

- 7.1 Represent of etch boat must be register and signing the register form in Race Office before 10.30 am of 26th August
- 7.2 Registration is conditional on the submission of the following documents:
 - a) Valid Measurement Certificate of ORC 2020.
 - b) A copy of the current insurance policy, which includes coverage of public liability (third person or property damage), or extension of public liability and third party damage cover up to at least €601.012,00 according to RD 62/2008.
 - c) Seaworthiness Certificate and Registry for course of this Race.
 - d) For crew members that are Spanish or legal residents of Spain, also include a current state sports federation license 2020. Foreign crew members who are not in possession of a sports federation license will provide a photocopy of their passport to the regatta office during the registration period.
 - e) Foreign participants who are not in possession of a sport federal license must prove that they are covered by accident insurance covering participation in races and coverage in Spain.
 - f) List of crew members with D.N.I. or Passport number and ground contact telephone number.
 - g) Certificate of raft review (Off Shore Race)

- h) EPIRB Identify Number (MMSI) (Off Shore Race)
- i) Compliance Declaration signed.
- In case to display advertising, Real Federación Española de Vela autorotation according RFEV entry fees, regulation WS 20.8.2. (only boats with Spanish flag or foreign flag representing or competing for a club affiliated to the RFEV).

9- MEASUREMENTS AND INSPECTIONS

- 9.1 All boats must be require for Race Committee in Club Nàutic Garraf before 10.30 am 25th August 2020, for stamping, revision and security control. Last day for inspections will be 25th August at 20 pm.
- 9.2. Will be established appointment for measurement and inspections. These will be agreed upon receipt entry.
- 9.3. Any measurement and sealing equipment propeller unit will be made at boats arrived after 25th August at CN Garraf, without notice to Race Committee.

10- SCORING

The scoring system is set forth in the WORLD SAILING rule A4.1 (RRS).

11- RANKING

- 11.1 WILL BE ESTABLISHED A PRIZE FOR OVERALL WINNER AND WINNER IN REAL TIME.
- 11.2 The following rankings shall be established: ORC: Single-handle, double-handle and Full Crew. MINI 6.5 double-handle.
- 11.3 Mini 6.5 Class will be established group from 5 boats (total) and them racing in real time. Will be established 2 rankings, Prototype and Production boat, is required minimum 3 boats for division.

In case not arrived at minimum boats for establish group, they racing in Double-handle presenting its current ORC certificate.

11.4 . The group registries with more than 6 boats may be divided into Classes according Rule 201.1 of the RTC, except Mini 6.5.

12- SECURITY [NP][DP]

- 12.1 This regatta's safety guidelines will be considered as **Category 3 with live raft** and index >103° according with Offshore Special Regulations of WORLD SAILING.
- 12.2 All boats must be equipped with a VHF radio that receives Channel 9 and 16, and EPIRB, according to current disposition of the Marine Authority; they must take a mobile telephone on board, the number of which they shall provide at the time of registration.
- 12.3 In compliance with the Sailing Instructions, all boats will have current of their obligations to the Merchant Navy in terms of offices and certifications.

13- PRIZE AND SOCIAL EVENTS

- 13.1 The awards list will be posted on the official bulletin board (TOA).
- 13.2 Due to the current situation happened because of the state of emergency decreed by COVID-19, social events are conditioned according to the legislated by the Competent Authorities. Once defined, we will communicate through official channels.

14- BERTH

- 14.1 Officially registered competitors will be provided free mooring at the Club Nàutic Garraf from 15th August to 5th September 2020.
- 14.2 If any boat needs more mooring time, it must request it from the Organization, in writing before the start of the Race, and this will resolve the request as soon as possible and depending on availability.
- 14.3 The CLUB NÀUTIC GARRAF reserves the right to moor the boats at the berthing posts that is considered appropriate.

15- **RESPONSIBILITY**

All those who participate in this Regatta do so at their own risk and responsibility.

The Organizing Committee, and any individuals or entities involved in the event's organization, decline all responsibility for losses, damages, injuries or inconveniences that might occur to persons or things, on land or at sea, as a result of their participation in any of the races outlined in this official regatta notice.

We bring your specific attention to the Fundamental Rule number four (4), DECISION TO RACE, in Part 1 of the RRV which states:

"THE RESPONSIBILITY FOR A BOAT'S DECISION TO PARTICIPATE IN A RACE OR TO CONTINUE RACING IS HERS ALONE."

16- IMAGE RIGHTS

16.1 The image rights of the regatta are exclusive property of C.N. Garraf and RFEV.

- 16.2 The participants grant their authorization to sponsor(s) and organizing authority to use their personal or boat's images in any text, photographs or video editing with a publicity purpose by any media, including press, TV or internet advertising, such as editorial comments, information or advertising. The name and biographical material of participants may be used or reproduced by any known media.
- 16.3 The participants agree not to carry out or allow any act of reproduction, public communication, or images distribution of nautical test, without the prior authorization of C.N. Garraf.









- 16.4 Any publicity action unrelated to event's sponsor, yacht clubs or organizing committee carried out by participants, their sponsors or by people, entities and organizations directly /indirectly linked to them, carried out at yacht club's environs or in piers, provided must have prior authorization from Organizing Authority.
- 16.5 Failure to comply with this rule will suppose an automatic exclusion from the competition, without a refund of the registration fees of the regatta subscribers.

17- INFORMATION ON THE PROCESSING OF PERSONAL DATA-REGULATION (UE) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL (GENERAL DATA PROTECTION REGULATION-GDPR) INTENDED FOR TREATMENTS CARRIED OUT IN THE COVID-19 CONTAGION PREVENTION ACTIVITIES FIELD

Ms. Raquel Albacete based in Escullera de Ponent s/n 08871 Garraf (Sitges) will be the person in charge of processing the personal data of the people with access to the facilities of the yacht club CLUB NÀUTIC GARRAF, informs you in accordance with art. 13 of EU Regulation 679/2016 (in advance "General Data Protection Regulation" or "GDPR") where your personal data (in advance "data") will be subject to treatment (according to the definition of "treatment" or the article 4.2 of the GDPR) in the manner and for the purposes indicated below.

1. Purpose and legal basis of the treatment

The personal data you provide or that are obtained by reason of your participation in the regatta or access to the C.N.Garraf will be processed in order to avoid the spread of COVID-19.

The legal basis of the treatment is identified in the implementation of the security protocols against contagion in accordance with article 27 of Royal Decree-Law 21/2020 of June 9, on urgent measures of prevention containment and coordination to face to the health crisis caused by COVID-19.

The person responsible for the treatment of data will processes particular categories of personal data, meaning data related to the state of health, since the treatment is necessary to fulfill the obligations of the person responsible in terms of security and social protection as established in Article 9 of the GDPR.

2. Personal data object of the treatment- General data: name, surname, telephone.

Particular categories of personal data in accordance with art. 9 of the GDPR: health status data in particular the body temperature measured at the entrance to the facilities of C.N.Garraf or in case there are symptoms related to COVID-19 after access.

In this case the data will be communicated to the competent doctor and to the person in charge to established the current regulations and instructions.

3. Nature of data provision

We recommend that in purpose indicated to the provision of your data is mandatory. If you deny the access to the information it won't be possible to access the facilities to the yacht club.









4. Duration of the conversation of your data.

Your personal data and body temperature are needed to be able to detect any presence of any symptoms of COVID-19 and to avoid any possible contagion. Once the body temperature is collected if it's fewer than 37.5 ° you will be able to have access to the yacht club C.N. Garraf the measured temperature will not be stored.

In case the body temperature is over the previous temperature threshold the C.N. Garraf is obliged to identify the person concerned and record the body temperature to document the reasons that prevented access to C.N.Garraf. For this reason, your personal data and data related to your body temperature will be recorded and stored for a period of 14 days. The same thing will happen if the body temperature is detected once you're in the facilities of the yacht club.

5. Data use method

The data processing is carried out using an appropriate paper support that guarantees the security and confidentiality of the data in accordance with the provisions of Chapter II (Principles) and Chapter IV (Data controller and data processor) of the GDPR. The processing of personal data may consist of the collection, registration, storage, consultation, communication, cancellation or destruction of the data.

6. Extension of the circulation of the data

Your data will be processed directly by the Club who will detect your temperature when you enter the facilities. Without your express consent (in accordance with article 6 letters b) and c) or the GDPR) the controller may communicate your data to the health authorities as well as to all other subjects to whom communication is mandatory.

7. Data diffusion

Your data will not be disclosed to undetermined people.

8. Transfer of data abroad

Data will not be transfer outside the European Union

9. Person in charge of data processing

10. Exercise of rights

As an interested party in the processing of data, we inform you that you have the possibility to exercise the rights provided for by the GDPR a specifically:

a) The right in accordance with article 15 to obtain confirmation that the processing of data concerning him is in progress and in this case, to obtain access to the data and the following information: (I) the purpose of the treatment (II) the type of data in order, (III) the recipient or categories of recipients to whom the data have been or will be communicated especially in the case of third countries or international organizations (IV) where possible the expected period that the data will be retain, if not possible, the criteria used to determine this period; (V) the existence of the right of the person concerned to request the controller to correct or delete the data or limit the processing or to object to its processing; (VI) the right to lodge a complaint with a supervisory authority in accordance with article 77 et seq. of the GDPE; (VII) if the data is not collected from the interested party all available information on its origin; (VIII) the existence of an automated decision-making process including the profiling referred in article 22 paragraphs 1 and 4 of the GDPR, at least in such cases of important information on the logic used and the importance and expected consequences pf such treatment for the person concerned.









- b) The right to be informed of the existence of adequate safeguards in accordance with article 46 of the GDPR in relation to the transfer if the data is transferred to a third country or to an international organization;
- c) The person concerned will also have (where appropriate) the possibility to exercise the right mentioned in the article 16-21 of the GDPR (the right of rectification, right to be forgotten, right of limitation of processing, right to data portability, right of opposition).

We inform you that the controller undertakes to respond to your request no later than one month after receiving the request. This period may be extended by two months if necessary taking into account the complexity or the number of applications received.

Article 27. Protection of personal data

The processing of personal information that is carried out as a result of the development and application of this royal decree-law shall be done in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and out of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/CE, in Organic Law 3/2018 of December 5th on the Personal Data and the Guarantee of Digital Rights and as set out in Article 8. 1 and 23 of Law 14/1986 on 25 April, General of Health. In particular the obligation to inform interested parties of the data obtained by the subjects covered by this Royal Decree-Law shall be in accordance with Article 14 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 taking into account the derogations and obligations provided for in paragraph 5 thereof.

The purpose of the treatment shall be the monitoring and epidemiological surveillance of COVID-19 in order to prevent and avoid exceptional situations of particular gravity, taking into account reasons of essential public interest in the specific field of public health and for the protection of the vital interests of those affected and other natural persons under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016. The data collected will be used exclusively for this purpose.

The person responsible for the treatment shall be the Autonomous Communities, the cities of Ceuta and Melilla and the Ministry of Health within the scope of their respective competences which shall ensure the implementation of the mandatory security measures resulting from the relevant risk analysis taking into account that the processing affects special categories of data and that such processing will be carried out by public administrations obliged to comply with the National Safety Scheme.

The exchange of data with other countries shall be governed by Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 taking into account Decision No 1082/2013/EU of The European Parliament and of the Council of 22 October 2013, on serious cross-border threats to health and the revised International Health Regulations (2005) adopted by the 58th World Health Assembly held in Geneva on 23 May 2005.









18- LOCAL MARINE REGULATION

RD 62/2008 dispose of safety of live at sea, maritime and navigational security conditions applicable in sportive nautical events.

The participants are advised, before the start the Race, the bots may participate only if they are legally dispatched to navigate the waters through which the test will pass, and whether their employers have sufficient qualifications for their government.

Participants should declare, well in advance of the start the Race, the insurance underwritten, if any, including the risks covered and the limits of liability in accordance with the Notice Race, covered for participation in nautical-sporting events.

[NP][DP] Annex A – SECURITY PROTOCOL IN RELATION TO COVID-19

- a. The Access to the facilities of the regatta is conditioned to the body temperature control.
- b. All participant and support people are required to wear a mask:
- 1st : At all times while are afloat for ORC boats full crews.

2nd: In all closed premises or in open places when the minimum distance of 1,5 meters cannot be respected.

3rd: When boarding in rescue boats and any boat of the Regatta, Protest and Measurement Committees. Mask and gloves should only be thrown into the containers provided for this, duly marked.

c. Participants and support people are obliged to respect the capacity and the turns of access, where appropriate to:

1st changing rooms and showers. It is strictly forbidden to deposit clothing and bags and these must be located in the places designated for it (lockers, etc.), avoiding common areas and must be removed from the venue every day at the end of the activity as well as going barefoot.

2nd: bar, restaurant and social rooms.

- d. All participants and support people are obliged to clean their hands with frequency and the use of hydrogels when accessing closed rooms.
- e. Participants and support people are obliged to use the one-way lanes when traveling through the interior of the facilities.
