



Annex Health Agreement





From April 28 april unitll May 4 2021 Grade 3

Within the framework of the current context, a reenforced health agreement is requested for the authorised events by the Authorities.

This agreement shall be punctiliously respected by the whole of the competitors who intend to participate to the Pornichet Select 2021.

If some shortcomings would be noted, the Organization reserves the right to cancel the paricipation of a competitor to the event.

1. Sitting of the event:

It will take place on the side of the North pier of the Pornichet Harbour and includes two areas

- A village composed of:
- o A removable struture (100m2 marquee)
- Two bungalows
- o Three chalets
- o A container for material storage
- A reception pontoon for all the boats (80).

The event shall take place behind closes doors. That implies the following measures

- -> The sitting of the event (Village and pontoons) is **closed to the public**. It is delimited by barriers and the access is controlled by a security guard (badge, attendance book, temperature measurement, etc)
- > The event sitting is exclusively reserved for the organizers¹ and the skippers. Accreditation wristbands to enter are mandatory. Writsbands can be collected at the entrance to the Village.
- -> The Village is opened from 09.00 to 19.00, from Wednesday April 28 to Saturday May 1st inclusive. Any attendance outside of the schedule are forbidden, except the safety guards making their one's round.
- -> The accompanying personns (family, friends, coaches etc...) shall not be allowed in the village.

2. Arrival on the event:

Upon your arrival at the event site (by road or sea), and from Wednesday, April 28, 10 am, please collect your accreditation wristbands with the security officer at the entrance of the village. It will be required to circulate on the village and pontoon.

3. Wearing the mask and barriers gesture:

Wearing the mask and barriers gesture respect are mandatory on the event sitting (village and pontoon) and throughout the duration of event.

Hydroalcoholic gel be available to access the village and the pontoon.

The skippers shall be alone onboard their boat

Futhremore mask shall be weared

- On the boat at the pontoon
- The deaparture day until being in complete autonomy

Mask may be only set off inside the boat if and only if the skipper is alone onboard

If exceptionnaly one person has to climb onboard, she shall onviously keep her mask onboard, put on hydroalcoholic gel and keep a physical distance of 1m.

Each skipper shall be equiped with hydroalcoholic gel onboard his boat and shall put some before going down on the pontoon.

4. Shedule of the event:

- Wednseday April 28:

14.00 to 18.00 : Welcome in the Racing Head Office in Pornichet. Registration confirmation, safety material controls.

Welcome drink canceled

- Thirsday April 29:

09.00 to 18.00 : Registration confirmation, safety material controls.

LACL party and crew diner canceled

- Friday April 30:

09.00 to 18.00 : Registration confirmation, safety material controls.

HSD brunch canceled

18.00: <u>Visio skipper briefing</u> 19.00: <u>Visio rooky briefing</u>

- Saturday May 1st

Skipper breakfast canceled

08.30: Visio weather forecast briefing

13.00 : Start in the bay

Tuesday May 4

12.00: Results announcement

Closing cocktail canceled

5. PCR test:

Competitors are required to provide by mail to the organizers a negativ PCR test of less than 72h. Competitors having to be on the site Wesnesday April 28, the provided test shall not be earlier than April 25 2021.

Without providing this test, competitors shall not participate to the LA Pornichet Select 2021, and shall not be admitted on the Event Siiting

6. Certificates of honour:

Competitors shall:

- Outside from the village, respect of the barrier gestures (as wearing a mask anywhere) and physical distanciations from his arrival on the siiting until the start.
- The start day, Saturday May the 1st at last, provide by mail to the organizer the self evaluation questionnaire (see here under).

7. Movement on the pontoon:

A direction of movement will be set up on the pontoon with marking on ground with single entry and way out.

8. Official Board:

The official board shall be dematerialized. It shall be available on the Event website.

More, a WhatsApp group « PS2021 – coureurs » will allow to communicate with all the competitors.

For those who don't have the WhatsApp app, feel free to download it now.

9. Registration chain:

- The registration confirmation will take place under the marquee et only by appointment (see link) 2 welcome stations will be provided for this purpose
- A ground marking will make it possible to materialize a waiting area.

This confirmation will:

- -> validate that all the informations provided upstream is correct. This require necessarely sending all the elements upstream by mail and before arriving in the event sitting
- -> recover the tracker against the deposit as requested in Art 12.1.2 of the NoR

10. Safety controls:

Safety controls will be done on the site and will take place only <u>by appointment</u>. They will be outside of the boat on the pontoon. We will send you soon the required material list.

11. Briefing

The briefings (security, rookie and weather) will take place only on visio with GoToMeeting (GTM) available on PC, tablet or mobile phone.

12. Exit of boats on the starting day:

Skippers shall wear their mask until being in complete autonomy onboard their boat.

The volunteers on the help ribs shall wear their marsk while towing and shall remain so if they are 2 onboard.

13. Finish and stopover:

When a competitor crosses the finishing line or has to make a stopover, he shall again wear his mask,

14. Prize ceremony:

Only the three first of the « proto » and the « series » will be invited, repecting barrier gestures and physical distancing.

15. What to do in case of COVID 19 symptoms or positiv test

While attending the event, each person concerned must immediately report to the organizer, who shall inform the ARS (*Health Regional Agency*), if:

- A test is positive for COVID-19.
- She is starting to show symptoms of COVID-19.
- She had close contact with a person suffering from symptoms of COVID-19.
- The ARS declared her as a contact case

Note that the symptoms of COVID-19 are fever, cough, shortness of breath, fatigue, headache, runny nose (rhinitis), sore throat (pharyngitis), loss of taste or smell, a rash and / or discoloration of the fingers or toes and / or any other symptom that the World Health Organization may specify from time to time.

Outside the event site, each person must observe barrier gestures and social distancing rules (eg hygiene rules, hand washing, disinfectant wipes, personal protective equipment).

A decision of the Organizing Authority to exclude a person and / or deny him access to the site on the basis of an assessment that the person concerned is infected, is final and cannot be contested for any reason and instance.

Although this health protocol is designed to reduce the risk of transmission of the COVID-19 virus, everyone recognizes that it is not possible to eliminate this risk entirely. Everyone assumes the risk of disease and its consequences linked to COVID-19 following their participation or presence on the LA Pornichet Select event, and accepts (in their own name and in the names of the successors and / or beneficiaries) that the The Organizing Authority, and its employees, assume no responsibility for such disease and its consequences, unless it is proven that the disease is the result of willful misconduct on the part of the Organizing Authority.
